

Financials

AXA Mansard Insurance plc has witnessed tremendous growth since its recapitalization in 2002. At AXA Mansard Insurance plc, we have been in the forefront of the changing times by retooling and reinventing ourselves to align more with our customers and to better meet their goals and aspirations.

This has reflected greatly in our financial performance in the last ten years both on our income lines and our balance sheet size.

From 2004, AXA Mansard Insurance plc Gross Premium Written (GPW) grew from N136 million to N47.5billion in 2020, Claims payment increased from N16.4million to over N20.2billion in 2020. The Group grew the insurance liabilities from N17.4million in 2004 to N29.5billion in 2020. These liabilities drove the growth of the Group's assets from N612million in 2004 to N94.4billion and Shareholders' funds of N33.9billion in 2020 from N451million in 2004.
